## Public Spaces Protection Order

### Anti Social Behaviour Crime and Policing Act 2014 s.59

Notice is hereby given that London Borough of Hillingdon ("the Council") has made the following Public Spaces Protection Order under section 59 of the Anti-Social Behaviour Crime and Policing Act 2014 ("the Act"):

1. The land described in the schedule below ("the restricted areas") being land in the area of the Council is land to which the Anti-Social Behaviour Crime and Policing Act 2014 applies and will be protected by the making of this Order
2. The Order may be cited as the **Heathrow Villages Public Spaces Protection Order** ("the Order") and came into force on << DATE>> for a duration of 3 years
3. The effect of the Order is to impose the following conditions on the use of the land:

#### Conditions in the Order which are prohibitions:

- (a) In the restricted areas a person commits an offence if without reasonable excuse he or she continues to carry out activities from which they are prohibited namely:
  - i. **Spitting saliva or any other product from the mouth onto the ground without making any attempt to collect or eradicate the saliva or product**
  - ii. **Urinating or defecating in a public space except in a premises (or using a receptacle) designed for the purpose**
  - iii. **Being verbally abusive to any person or behaving in a way which causes or is likely to cause harassment, alarm or distress to another person**
  - iv. **Leaving the engine of a stationary or parked vehicle running**

#### Prohibition with exceptions:

- v. **Parking a commercial vehicle in a Council operated car park associated with a Council operated leisure or Green space facility unless:**
  - a) **The driver or passenger/s are attending the car park for the genuine use of the leisure or green space facilities provided by the London Borough of Hillingdon;**
  - b) **The driver or passenger/s are customers of businesses within the Council operated leisure or Green space facility;**
  - c) **Directed or authorised to enter the car park by a uniformed police officer or authorised officer of the London Borough of Hillingdon;**
  - d) **The vehicles are used for deliveries to the leisure or green space facilities;**

- e) **The vehicles are used for the maintenance or repair of the leisure or green space facilities.**

### Conditions in the Order which are requirements:

(b) In the restricted areas a person commits an offence if without reasonable excuse he or she fails to comply with any activity that they are required to undertake namely:

- **Leave the area when required to do so by an authorised officer and not return within 48 hours**

A person who fails without reasonable excuse to comply with conditions in sections (a) and (b) above, commits an offence under section 67 of the Act and is liable on summary conviction to a fine not exceeding level 3 on the standard scale or fixed penalty notice of a maximum £100.

### Schedule of the restricted areas

All land in the open air owned, maintained or managed by the Council within the Ward of Heathrow Villages

### General

An authorised officer means a Local Authority Employee, a person designated by the Local Authority, a Police Officer or Police Community Support Officer.

The Council is satisfied that the conditions set out in sections 59, 64 & 72 of the Act have been satisfied and that it is in all the circumstances expedient to make this order for the purposes of reducing anti social behaviour in the restricted areas. The Council makes the order because anti social behaviour in the restricted areas has had a detrimental effect on the quality of life of those in the locality. The effect or likely effect of this is of a persistent or continuing nature such as to make this unreasonable, and justifies the restrictions imposed in this order. If any "interested person" desires to question the validity of this Order on the grounds that the Council had no power to make it or that any requirement of the Act has not been complied with in relation to this Order, he or she may apply to the High Court within six weeks from the date on which this Order is made.
